REQUEST FOR VOLUNTARY SUSPENSION – QUESTE COMMUNICATIONS LTD (ASX:QUE)

We refer to the Company's request for a trading halt dated 17 May 2016 – this request was made (as required by ASX) pending the release of a market announcement in relation to a potential proposed transaction concerning an acquisition by the Company and ancillary matters.

The terms of this market announcement is subject to, inter alia, the Company's receipt of ASX's position in response to a submission made by the Company in relation to the application of the Listing Rules to the potential proposed transaction (and ancillary matters).

ASX has advised that it will not be able to respond before the market opens on Friday, 20 May 2016, prior to the expiry of the maximum 2 business day trading halt period.

Accordingly, we request a transition of the Company's trading halt to a voluntary suspension in relation to the Company's listed shares pending the release of this market announcement.

The following information is provided in relation to this voluntary suspension request pursuant to Listing Rule 17.2:

(1)	<i>Reasons for the voluntary suspension</i>	Pending the release of a market announcement in relation to a potential proposed transaction concerning an acquisition by the Company and ancillary matters, which is subject to receipt of ASX's position in response to a submission made by the Company in relation to the application of the Listing Rules to the potential proposed transaction (and ancillary matters).
(2)	Length of voluntary suspension	Until such time as the market announcement referred to in (1) is released on ASX. At this stage, this is expected to be within the next week (subject to receipt of ASX's position referred to above).
(3)	Events expected to happen to end the voluntary suspension	Upon the release of a market announcement in relation to the matter referred to in (1).
